6. 16. The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline information/data submitted by the School to the Board.

17. The genuineness of information / documents / data submitted shall be of school and in case, if found otherwise, invite action as per affiliation Bye laws-2018
18. The school shall be responsible for submission of any pending compliance, reply of show cause /legal notice or submission of date/information sought by the Board. The extension of 05 years shall be from the date of expiry of validity of extension of affiliation
19. The school is required to remit pending fee, if any
20. The extension of affiliation is being granted as one time measure. However, the cases where the Show Cause Notice is communicated or grievance / legal cases are pending against the school, the Board will take appropriate action
21. The school shall renew all mandatory safety certificate i.e Safe Drinking Water & Health and Hygiene certificate and Building Safety Certificate from concerned Govt authorities time to time

The school shall also maintain record of certificate, compliances, data and other records/information and shall produce all such records before Board and appropriate Government Authorities when asked for, failing which action will be taken as per Affiliation-Bye-Laws of the Board.
